PARISHIONER: \$2822.00 per student per year

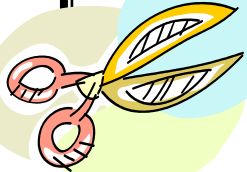
12 Month Auto Payment Plan (August - July) = \$235.17 per month

NON-PARISHIONER: \$3661.00 per student per year

12 Month Auto Payment Plan (August-July) = \$305.08 per month

9 Month Auto Payment Plan (September - May) = \$406.78 per month



## 3 YEAR OLD PRESCHOOL

4 day program (Mon, Tues, Thurs, Fri 8:00-11:00am) must be age 3 by 9/15/17

Provides 12 hours of Preschool

**Tuition:** \$1200.00 per student per year

(9 or 12 Month Auto Payment Plans available)

## 4 YEAR OLD PRESCHOOL

4 day program (Mon, Tues, Thurs, Fri) must be age 4 by 9/15/17

Full Day and  $\frac{1}{2}$  Day Classes Available - **NO COST/STATE FUNDED**

## 5 YEAR OLD PROGRAM:

4 day program (Mon, Tues, Thurs, Fri Full Days) must be age 5 on 9/15/17

and **NOT** planning to attend kindergarten in the 2017-2018 year.

**Tuition for 5 Year Old Program:** \$1560.00 per year
